



SEASON PASS ENROLLMENT AGREEMENT

MONTHLY PAYMENTS

The Forest Preserve Golf SEASON PASS is active April 1 through October 31. The first \$79.99* installment is due upon enrollment, with subsequent \$79.99 installments charged the 1st day of each following month, through October. Your payment information will be held in a secure digital environment. If a monthly charge fails to go through, benefits will be suspended immediately, and to reinstate a membership, all past-due monthly charges must be paid. The Season Pass renews automatically each year, and members are enrolled until they provide written, expressed cancellation, detailed below.

*Initial enrollment payment will be prorated for mid-month enrollees.

ENROLLEE BENEFITS

TEE TIMES Tee times can be made first come, first served, up to seven days in advance. Early-Bird Twilight Play at Chick Evans, George Dunne, Highland Woods, Indian Boundary and Joe Louis "The Champ" is available at a reduced rate of \$25, Monday-Friday, and \$35 Saturday-Sunday. Early-Bird Twilight Play at Billy Caldwell, Burnham Woods, Edgebrook, Meadowlark and River Oaks is available at a reduced rate of \$18, Monday-Friday, and \$25 Saturday-Sunday. Tee time rates apply whether you walk or ride.

DRIVING RANGE USAGE Enrollees have access to unlimited driving range balls at Highland Woods and George Dunne National - two buckets at time. At Harry Semrow Driving Range, enrollees may purchase range balls buy-one, get-one. Replay rounds will be charged at the same rate or the prevailing replay rate, whichever is lowest.

We may, from time to time, offer additional promotional rates or other golf specials. These will be communicated to members in advance and the appropriate rate charged at check-in.

TRANSFERABILITY, RENEWAL AND CANCELLATION

TRANSFERABILITY The Season Pass and its benefits are not transferable, and may not be shared with other customers.

RENEWAL AND CANCELLATION The Season Pass renews automatically each year, unless the enrollee provides written 30-day notice. Written notice is required to cancel the membership and can be submitted at any time by emailing info@forestpreservegolf.com. You must provide an email address to join the membership, and the written cancellation must come from the email provided at joining. Upon receipt of written notice to cancel, there will be one final monthly charge and 30-day period of benefits. Forest Preserve Golf and/or any of its family of courses may cancel this program at any time.

LIMITATION OF LIABILITY

Forest Preserve Golf and its family of courses and driving ranges will not be liable for any lost profits or for any indirect, incidental, consequential, punitive or other special damages suffered by the player arising out of or related to this Agreement even if Forest Preserve Golf has been advised of the possibility of such damages. In no event shall the total cumulative liability of Forest Preserve Golf in connection with the Agreement from all causes of action of any kind (including tort, contract negligence, strict liability, breach warranty and fundamental breach) exceed the total amount paid by the player to Forest Preserve Golf under this Agreement.

ASSUMPTION OF RISKS AND INDEMNIFICATION

In consideration for the privilege of using the Forest Preserve Golf and its family of courses and driving range Facilities, each person entering upon or using the Forest Preserve Golf and its family of courses and driving range Facilities agrees:

(a) to accept all risks associated with the use of the Forest Preserve Golf and its family of courses and driving range Facilities and to release their employees, agents, officers, Directors, Successors, and Assigns from and indemnify and defend Forest Preserve Golf and its family of courses and driving ranges against any and all claims, whether or not based on the acts or omissions of the Forest Preserve Golf and its family of courses and driving ranges, arising out of or in any way connected with such use of the Forest Preserve Golf and its family of courses and driving range Facilities to the fullest extent allowed by law; and (b) to assume sole responsibility for their personal safety and the safety of their personal property brought upon, used or stored at the Forest Preserve Golf and its family of courses and driving range Facilities; Forest Preserve Golf and its family of courses and driving ranges shall not be responsible for any loss or damage to any personal property brought upon, used or stored at the Club Facilities, whether in lockers or elsewhere; and (c) Each Member and Member's designee further agrees to be responsible and liable for any property damage and/or personal injury which such Member or designee causes, or which is caused by such Member's or designee's authorized users or guests.

REFUSAL OF PRIVILEGE

Forest Preserve Golf and its family of courses and driving range facilities shall have the right to refuse golf course privileges to anyone who is judged to be in violation of the established rules and regulations herein.
